Dear Parents

As per the orders received from Directorate of Education, Govt. of Haryana dated 09.07.2021 had issued guidelines for reopening of schools for classes VI to VIII from 23.07.2021. This will be subject to "written consent of their parents/guardians and Health Fitness Certificate issued from any PHC/CHC/Civil /Pvt. Hospital", which should not be older than 72 hours/ 3 days on the day the student joins the school. The School shall be functional from Tuesday, 3rd August 2021 between 09:30 am to 1:00 pm. Schedule of the same would be shared by the respective class teachers.

Although we have made all arrangements for the safe conduct of teaching by thoroughly implementing health guidelines and instructions issued by Government of India, however your cooperation is absolutely necessary to support us in holding tutorials safely by ensuring the following:-

- Your ward carries pocket hand sanitizer in a transparent bottle, hand gloves (optional), transparent drinking water bottle and only permissible stationery items as per the schedule.
- All students should come in proper school uniform.
- 3. Your ward should cover nose and mouth with face mask.
- 4. Guide your ward to follow social distancing norms strictly.
- There will be no lunch break, hence please ensure that your ward has had proper breakfast before sending him or her to school.
- Instruct your ward not to exchange or loan articles in class, follow all instructions displayed in the school and communicated to them, to avoid contact with unknown persons, throw used tissue/ face mask into closed bins immediately after use.
- Guide your ward for safe mode of transportation for going to school and returning back to the home.
- 8. You need to send a Health Fitness Certificate issued from any PHC/CHC/Govt / Pvt. Hospital clearly mentioning that your ward is not infected or having symptoms of Covid-19. In case, your ward is not feeling well, you should consult the doctor and act as per the advice and do not send your ward to school.

We are confident that as concerned and aware parents, you will take necessary steps to help us in conducting guided teaching smoothly. You are requested to send us consent letter, every time he/she is attending the school in the format attached (Annexure A).

Remember "Unlock does not mean the end of Pandemic". Hence always wear your mask, sanitize/wash your hands and maintain social distance whenever & wherever required.
